#### **RESOLUTION 2302**

RESOLUTION OF THE BOARD OF THE CUMBERLAND-DAUPHIN-HARRISBURG TRANSIT AUTHORITY (CDHTA) TO ADOPT PROPOSED AMENDMENT TO THE ARTICLES OF INCORPORATION FOR THE CDHTA TO INCREASE ITS TERM OF EXISTENCE TO A DATE NOT EXCEEDING 50 YEARS FROM THE DATE OF THE APPROVAL OF THE ARTICLES OF AMENDMENT AND TO TAKE ANY AND ALL OTHER ACTIONS RELATED THERETO

WHEREAS, the Cumberland-Dauphin-Harrisburg Transit Authority (hereinafter "Authority") is a body corporate and politic, incorporated by the Counties of Cumberland and Dauphin and the City of Harrisburg and is existing under and is governed by the provisions of the Municipalities Authorities Act, 53 Pa.C.S.A. § 5601 et seq., which codifies and amends the Municipalities Authorities Act of 1945, as amended and supplemented (hereinafter the "Act"); and

WHEREAS, by this duly adopted Resolution dated July 27, 2023, the Authority proposes to amend its Articles of Incorporation to add a provision to increase its existence to a date not exceeding fifty (50) years from the date of the approval of the Articles of Amendment pursuant to the powers vested in it by the Act; and

WHEREAS, the Authority thereafter shall submit the proposed amendment to its Articles of Incorporation to the Board of Commissioners of Cumberland and Dauphin County and to the Council for the City of Harrisburg for adoption in accordance with the applicable provisions of the Act; and

#### NOW THEREFORE BE IT RESOLVED that:

1. The Board of the Authority proposes to amend its Articles of Incorporation to add a provision to increase its existence to a date not exceeding 50 years from the

date of approval of the Articles of Incorporation and to reduce the number of Dauphin County votes from three to two.

- 2. The Board of the Authority directs that the proposed amendment be submitted to the Board of Commissioners of Cumberland and Dauphin County and to the Council for the City of Harrisburg for adoption in accordance with applicable provisions of the Act.
- 3. In the event that any provision, section, sentence, clause or part of this Resolution shall be held invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of this Authority that such remainder shall be and remain in full force and effect.
  - 4. This Resolution shall be effective immediately.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Cumberland-Dauphin-Harrisburg Transit Authority that it authorizes and directs its Chairman, Executive Director and Solicitor to take such action as may be necessary to carry out the intent and purpose of this Resolution.
